Rating Rationale

Acuite has reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.20.50 Crore bank facilities of Vandemataram Projects Private limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Vandemataram Projects Private Limited, incorporated in 2006, is an Ahmedabad based company engaged in civil construction work for residential projects and caters to the government under the Pradhan Mantri Awas Yojana in Gujarat. The present Promoters of the company are Mr. Arvind Devshibhai Limbani, Mr. Narsinhbhai Ratanshibhai Patel and Mr. Hasmukhbhai Chhganbhai Patel.
