Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 29.90 crore bank facilities of Rudai Lighting Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Rudai Lighting Private Limited (RLPL), established in 2016, is a Jaipur-based company engaged in manufacturing of LED Street Light, LED Lights. The Directors, Mr. Uday Parnami and Ashok Parmani are enriched with more than four decades of experience in the field of warehousing, storage services to national and international companies. RLPL's head office is located in Jaipur (Rajasthan).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
