Rating Rationale

Acuité has withdrawn the long-term rating of '**ACUITE BB-**' (**read as ACUITE double B minus**) on the Rs.10.00 crore bank facilities of Indiacrete Ready Mix Private Limited. The rating withdrawal is in accordance with Acuité's policy on withdrawal of rating. The rating continues to be flagged as "Issuer Not-Cooperating".

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

Mumbai based, Indiacrete Ready Mix Private Limited was incorporated in 2014 and commercial production begins from FY 2016. The company is engaged in manufacturing ready mix concrete (RMC) which find its application in construction Industry. In addition to producing basic grade concrete ranging from M10 to M80, company produce customized special types of concrete for different applications like fibre reinforced concrete, water proof concrete, and high volume fly ash concrete among others. The company is managed by two civil engineers namely, Mr. Imran Shaikh and Mr. Sandeep Sawant who have experience of more than two decades in construction industry. It caters to reputed customers like Shapoorji Pallonji, L&T, Piramal etc.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality
