Rating Rationale

Acuite has reaffirmed the short-term rating of ‘ACUITE A4’ (read as ACUITE A four) on the Rs.7.50 crore bank facilities of Jedi Dia India Private Limited (JDIPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Mumbai based Jedi Dia India Private Limited (JDIPL) was incorporated as a private limited company in 2013 and is promoted by Mr. Darpil Narendra Shah and Mr. Devang Sevantilal Shah. JDIPL is engaged in the trading and manufacturing of cut and polished diamonds of less than 1 carat and is totally into exports to Hong Kong and USA markets.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
