Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 12.10 crore bank facilities of Tirupati Cold Storage (TCS). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Tirupati Cold Storage(TCS) was established in 2015 as a partnership firm by Mr. Manoj Patidar and Mr. Kashiram Patidar. The company is engaged in providing potato cold storage facility for Pepsico, Technico Pty Limited, Balaji, Haldiram and Parle. The firm has installed capacity to store 7800 metric tonnes per annum (MTPA). The company has its cold storage facility at Harsodan (Ujjain).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to
