Acuité has downgraded the long-term rating of '**ACUITE B**' (**read as ACUITE B**) to '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs. 5.15 crore bank facilities of SREE RAJALAKSHMI PROCESSING MILLS (SRPM). This rating is now an indicative rating and is based on best available information.

The downgraded is reflected by irregularities in banking conduct.

Established in 2015, SRPM is an Erode (Tamil Nadu) based partnership firm promoted by Mr. K V Easwaran. The firm is engaged in printing of woven and knitted fabrics along with home furnishings. The entity has a processing plant at Erode with an installed capacity of 45000 meters per day. It is also certified by GOTS (Global Organic Textile Standards).

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
