### Rating Reaffirmed and Issuer not co-operating

### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs. 5.15 crore bank facilities of Sree Rajalakshmi Processing MILLS (SRPM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Established in 2015, Sree Rajalakshmi Processing MILLS (SRPM) is an Erode (Tamil Nadu) based partnership firm promoted by Mr. K V Easwaran. The firm is engaged in printing of woven and knitted fabrics along with home furnishings. The entity has a processing plant at Erode with an installed capacity of 45000 meters per day. It is also certified by GOTS (Global Organic Textile Standards).

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
