**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 225.00 crore bank facilities of Pravara Renewable Energy Limited (PREL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Pravara Renewable Energy Limited (PREL) was promoted by Gammon Infrastructure Projects Limited (GIPL) in 2008 to implement the 30 MW bagasse based co-generation power project at Pravaranagar in Ahmednagar (Maharashtra) on Build Own Operate and Transfer basis. The directors of Pravara Renewable Energy Limited are Mr Subhrarabinda Birabar, Mr Hemant Madansingh Chandel, Mr Jitendra Dattatraya Patil.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
