Rating Rationale

Acuité has downgraded the long-term rating to **'ACUITE B' (read as ACUITE B)** from **'ACUITE B+' (read as ACUITE B plus)** and reaffirmed the short-term rating of **'ACUITE A4' (read as ACUITE A four)** on the Rs. 6.25 crore bank facilities of Walia Builders on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Punjab-based, Walia Builders (WB) was established in the year 1994 as a partnership firm by Mr. Sanjeev Walia and Ms. Anju Walia. WB is engaged in undertaking civil contracts for the Military Engineering Services (MES) such as building construction, offices, road and others. The firm is registered as 'S' class contractor.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
