Acuite has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and the short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.6.00 crore bank facilities of Mahesh Sunny Enterprises Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Delhi based, Mahesh Sunny Enterprises Private Limited (MSEPL) was incorporated in 1999 by Mr. Bikram Singh and Mr. Mohinder Singh. The company is engaged in operating parking lot facilities in airport and collection of toll fees. Currently, MSEPL has contracts with Mumbai airport, Chandigarh airport, Delhi cargo, to name a few.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
