Rating Rationale

Acuite has downgraded the long-term rating to **'ACUITE B' (read as ACUITE B)** from **'ACUITE B+' (read as ACUITE B plus)** and reaffirmed the short-term rating of **'ACUITE A4' (read as ACUITE A four)** on the Rs.6.00 crore bank facilities of Mahesh Sunny Enterprises Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Delhi based, Mahesh Sunny Enterprises Private Limited (MSEPL) was incorporated in 1999 by Mr. Bikram Singh and Mr. Mohinder Singh. The company is engaged in operating parking lot facilities in airport and collection of toll fees. Currently, MSEPL has contracts with Mumbai airport, Chandigarh airport, Delhi cargo, to name a few.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
