Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) and reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs.14.25 crore bank facilities of Yadav Solvex Private Limited (YSPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Punjab based - Yadav Solvex Private Limited (YSPL) was incorporated in 2003. The company was previously engaged in the business of running a solvex plant. The company changed its line of business to rice shelling in the year 2014 -15. The company has 3 directors, namely Mr. Bhagwan Singh, Mr. Rajesh Yadav and Mr. Daya Ram involved in the day to day running of the business.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
