Rating Rationale

Acuité has downgraded the long term rating of Chenduran Cotspin India Private Limited (CC IPL) to '**ACUITE BB+**' (read as **ACUITE Double B plus**) from **ACUITE BBB-** (read as **Acuite Triple B Minus**) and short term rating to '**ACUITE A4+**' (read as **ACUITE A Four plus**) from **ACUITE A3** (read as **Acuite A Three**) on the Rs. 42.00 cr bank facilities. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Chenduran Cotspin India Private Limited (CC IPL) was incorporated as a Private Limited company in 1991. The company was started by Mr. P. Govindasamy who is has an experience of over three decades in the textile industry. The day to day operations are managed by his sons K. G. Senthil Kumar, Mr. P. G. Ramesh and Mr. P. G. Balaji who are on the board of the company. CC IPL is engaged in manufacturing of cotton and polyester yarn blend with counts ranging from 20s to 60s. The company's spinning unit is located in Dindigul, Tamilnadu and operates with an installed capacity of 34,656 spindles. The company has installed wind mills with capacity of 4.9 MW as on December 31, 2019.

Analytical Approach

Acuité has considered the consolidated business and financial risk profile of Chenduran Cotspin India Private Limited and Elkaypee Spinners Private Limited (hereinafter referred to as 'The Chenduran group') as both the entities are engaged in same line of business, common promoters and management. Extent of Consolidation: Full

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

CC IPL's rating was further downgraded and remained in 'ISSUER NON COOPERATING' status with CRISIL, through its rating rationale dated April 17, 2020. The reason provided by CRISIL is non-furnishing of information by CC IPL.
