**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.6.00 Crore bank facilities of BNSR Industries Limited (BNSR). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

UP-based, BNSR Industries Limited (BNSR) was incorporated in 1992 as a proprietorship concern by Mr. Shri Lal Gupta. Subsequently, its constitution got converted into Public Limited in 2008. BNSR is engaged in manufacturing of overhead transmission and distribution conductors and cables i.e. ACSR/AAAC and aerial bunched cables. The manufactured product portfolio find applications in power sector for power transmission over thousands of miles. The installed capacity of the new unit at Lucknow is 3000 MT per year.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
