Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.74 crore bank facilities of Knit King Apparels (KKA). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Knit King Apparels (KKA) is a Tirupur-based proprietorship concern established in 2007 by Mr. S. N. Velusamy. The firm is engaged in manufacture and exporting readymade garments primarily to U.K, Kuwait, among other countries. The firm has 300 sewing and cutting machines with a capacity to produce 5,000 pieces per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
