Acuité has withdrawn the long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs.6.00 crore bank facilities of Welmon Woodplast Private limited (WWPL). The rating withdrawal is in accordance with the Acuité's policy on withdrawal of rating. This rating is now an indicative rating and is based on the best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

Gujarat based - WWPL was incorporated in 2016 by Mr. Yogesh Patel, Mrs. Jaishree Patel and Mr. Haresh Vavadia to manufacture PVC (Poly Vinyl Chloride) sheets and WPC (Wood-Plastic Composites) of different varieties. The installed capacity is 450 Kgs per day, which is 3240 MTPA.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
