Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 15.00 crore bank facilities of Go Green Construction Solutions Private Limited (GGPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

GGPL was incorporated in 2012 by Mr. Ganesh K Ahire, Mr. Rishikesh Chopade, Mr. Bhushan Khairnar and Ms. Anita Khairnar. The company is engaged in the production of AAC blocks, an environment friendly product used in place of traditional clay in the construction industry. The manufacturing facility is located at Nashik (Maharashtra) with an installed capacity of 500 cubic meters per day. The company aims to provide quality AAC blocks to the developing cities and towns of Central India.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
