### Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) on the Rs. 15.00 crore bank facilities of Go Green Construction Solutions Private Limited (GGPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

#### About the Company

GGPL was incorporated in 2012 by Mr. Ganesh K Ahire, Mr. Rhishikesh Chopade, Mr. Bhushan Khairnar and Ms. Anita Khairnar. The company is engaged in the production of AAC blocks, an environment friendly product used in place of traditional clay in the construction industry. The manufacturing facility is located at Nashik (Maharashtra) with an installed capacity of 500 cubic meters per day. The company aims to provide quality AAC blocks to the developing cities and towns of Central India.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
