**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 15.00 crore bank facilities of Go Green Construction Solutions Private Limited (GGCSPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

**About the Company**

Go Green Construction Solutions Private Limited (GGCSPL) was incorporated in 2012 by Mr. Ganesh K Ahire, Mr. Rhishikesh Chopade, Mr. Bhushan Khairnar and Ms. Anita Khairnar. The company is engaged in the production of AAC blocks, an environment friendly product used in place of traditional clay in the construction industry. The manufacturing facility is located at Nashik (Maharashtra) with an installed capacity of 500 cubic meters per day. The company aims to provide quality AAC blocks to the developing cities and towns of Central India.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability:**

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
