### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus)on the Rs. 10.00 crore bank facilities of Rushi Stone Crusher (RSC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Mumbai based Rushi Stone Crusher is established in 1996, as a partnership firm. It is engaged in stone crushing business. It is led by its proprietor, Mr. Jayant Avhad. Stone quarry is in Sinnar, spread across 19 acres out of which 2 to 3 acres have been utilized. Its monthly production is around 15000 tonnes.

#### Unsupported Rating

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
