**Rating Rationale**

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 10.00 crore bank facilities of Rushi Stone Crusher (RSC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Mumbai based Rushi Stone Crusher is established in 1996, as a partnership firm. It is engaged in stone crushing business. It is led by its proprietor, Mr. Jayant Avhad. Stone quarry is in Sinnar, spread across 19 acres out of which 2 to 3 acres have been utilized. Its monthly production is around 15000 tonnes.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
