Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) on the Rs. 18.11 crore bank facilities of A INNOVATIVE FOOD PRODUCTS LLP (AIFPL). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

# **About the Company**

AIFPL established 2015 is based at Ahmedabad (Gujarat). Managed by Dhaval Patel The firm is engaged in manufacturing of ready to make Snack pellets (papaddam) made from wide range of base ingredients (including starch base) such as wheat, potato, corn, tapioca, rice and mixed grains to name a few. The manufacturing facility is located at Ahmedabad with installed capacity of 8000 MTPA.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
