Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 18.11 crore bank facilities of A INNOVATIVE FOOD PRODUCTS LLP (AIFPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

A INNOVATIVE FOOD PRODUCTS LLP (AIFPL) established 2015 is based at Ahmedabad (Gujarat). Managed by Dhaval Patel The firm is engaged in manufacturing of ready to make Snack pellets (papaddam) made from wide range of base ingredients (including starch base) such as wheat, potato, corn, tapioca, rice and mixed grains to name a few. The manufacturing facility is located at Ahmedabad with installed capacity of 8000 MTPA.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
