Rating Rationale

Acuité has reaffirmed its long-term rating to 'ACUITE D' (read as ACUITE Do)n the Rs.11.70 crore bank facilities of S K M Buildcon (SKMB). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
