Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) on the Rs.13.00 Crore bank facilities of Thangamman Textile Private Limited on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Thangamman Textile Private Limited (TTPL) is a Tamil Nadu based company and was incorporated in the year 2000. It is engaged in dying of fabrics. Its manufacturing facility is located at Cuddalore, Tamil Nadu with an installed capacity of eight tons per day. Directors of Thangamman Textile Private Limited are Nachimuthu Natrayan and Vinodh Natrayan.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
