Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 16.25 crore bank facilities of Shree Saibaba Green Power Private Limited (SSPL). This rating is now an indicative rating and is based on best available information.

Shree Saibaba Green Power Private Limited (SGPL) is promoted by Mr. Rajeshwar Vaijanathrao Bukey and Mr. Someshwar Manohararao Patil. SGPL has an operating 5 mega -watt (MW) solar photovoltaic power plant in Latur (Maharashtra) setup under the Jawaharlal Nehru National Solar Mission (JNNSM). SGPL entered into long term Power Purchase Agreement (PPA) with NTPC Vidyut Vyapar Nigam Limited (NVNL) for a period of 25 years at a fixed tariff of Rs.8. 73 per unit. The company started its commercial operations from February 2013.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
