Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 16.25 crore bank facilities of Shree Saibaba Green Power Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Shree Saibaba Green Power Private Limited (SGPL) is promoted by Mr. Rajeshwar Vijayanathrao Bukey and Mr. Someshwar Manohararao Patil. SGPL has operating 5 mega-watt (MW) solar photovoltaic power plant in Latur (Maharashtra) setup under the Jawaharlal Nehru National Solar Mission (JNNSM). SGPL entered into long term Power Purchase Agreement (PPA) with NTPC Vidyut Vyapar Nigam Limited (NVNL) for a period of 25 years at a fixed tariff of Rs.8. 73 per unit. The company started its commercial operations from February 2013.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
