**Rating Rationale**

Acuite has downgraded the long-term rating to ‘ACUITE B’ (read as ACUITE B) from ‘ACUITE B+’ (read as ACUITE B plus) on the Rs. 16.25 crore bank facilities of Shree Saibaba Green Power Private Limited on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Shree Saibaba Green Power Private Limited (SGPL) is promoted by Mr. Rajeshwar Vaijanathrao Bukey and Mr. Someshwar Manohararao Patil. SGPL has operating 5 mega-watt (MW) solar photovoltaic power plant in Latur (Maharashtra) setup under the Jawaharlal Nehru National Solar Mission (JNNSM). SGPL entered into long term Power Purchase Agreement (PPA) with NTPC Vidyut Vyapar Nigam Limited (NVNL) for a period of 25 years at a fixed tariff of Rs.8. 73 per unit. The company started its commercial operations from February 2013.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

**Limitation regarding information availability:**

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
