Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) on the Rs. 6.00 crore bank facilities of Arise Ceramic Private Limited (ACPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Gujarat based Arise ceramic Private limited was incorporated in 2013. ACPL is a ceramic division of Adroja Group promoted by Mr. Sagar Gajera based in Rajkot, Gujrat. The company is engaged in manufacturing of ceramic wall tiles of 300X450 mm (12X18) and 300X600 mm (12X24) ranges. Further, the company manufactures 300X300 mm (12X12) of floor tiles. The manufacturing facility is located in Gujarat having an installed capacity of 9000 boxes per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
