### Rating Rationale

Acuité has withdrawn the long-term rating of '**ACUITE B**' (**read as ACUITE B**) on the Rs.9.25 crore bank facilities of Pratham Cotspin Private Limited.

The rating withdrawal is in accordance with the Acuité's policy on withdrawal of rating. This rating is now an indicative rating and is based on the best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

Pratham Cotspin Private Limited (PCPL) was established in 2017 by Mr. Vilas Agrawal and Mr. Vaibhav Jain. PCPL is engaged in manufacturing of polyester yarn. The manufacturing unit of PCPL is located at Bhikangaon, Madhya Pradesh. The commercial operations started in July 2019.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
