### Rating Rationale

Acuité has reaffirmed and withdrawn the long-term rating of 'ACUITE B' (read as ACUITE B ) on the Rs.10 crore bank facilities of C N Coffee Trading CO (CNCTC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information. The rating has been withdrawn in accordance with Acuite's policy of withdrawal of ratings as applicable to the respective instrument/facility. The rating has been withdrawn on account of the request received from the company, and the NOC (No Objection Certificate) received from the banker.

### Non-cooperation by the issuer/borrower:
