Acuité has reviewed long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 20.00 crore bank facilities of Straddle Industries Private Limited (SIPL). This rating is now an indicative rating and is based on best available information.

Straddle Industries Private Limited (SIPL) (erstwhile Avichal Multitrade Private Limited) was incorporated in 2014 by Mr. Ketan Deshpande, Mr. Vaibhav Kulkarni, and Mr. Prafulla Bhat. The company is engaged in trading of mobile and mobile accessories, kitchen appliances, TVs, inverters and various other electronic products.

Non-cooperation by the issuer/borrower
