Acuité has downgraded and withdrawn the long-term rating to '**ACUITE BB+**' (read as **ACUITE double B plus**) from '**ACUITE BBB+**' (read as **ACUITE triple B plus**) on the Rs. 32.00 crore bank facilities of Maharashtra Samaj Ghatkopar (MSG). The rating withdrawal is in accordance with Acuité's policy on withdrawal of rating. The rating is now an indicative rating and is downgraded on account of information risk.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

About Maharashtra Samaj Ghatkopar

MSG, established in 1957 is registered under the Bombay Public Trust Act, 1950. Mr. Jesus Lall is the Chairman of the trust. MSG is a part of Universal Education Group (UEG). The trust manages a school and college and offers International General Certificate of Secondary Education (IGCSE). School is affiliated to the Cambridge University and College affiliated to Mumbai University.

About UEG

UEG has a presence in education since 2003. Mr. Jesus Lall is the founder. The group runs 44 educational institutions across 28 entities and offers K-12 education, degree and technical courses. While most of the entities are in education sector some of them are asset holding and provides supporting services to the institutes. The group has its presence in Maharashtra, Karnataka and Tamil Nadu.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
