Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE BB+' (read as ACUITE double B plus) on the Rs. 31.00 crore bank facilities of Supervalue Properties Private Limited (SPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

SPPL, incorporated in 2007, is promoted by Mr. Jesus Lall. SPPL is a part of Universal Education Group (UEG), SPPL manages a Pre-Primary school and provides infrastructure services to Universal Education Foundation.

About the Group

UEG has a presence in education since 2003. Mr. Jesus Lall is the founder. The group runs 44 educational institutions across 28 entities and offers K-12 education, degree and technical courses. While most of the entities are in education sector, some of them are asset holding and provides support services to the institutes. The group has its presence in Maharashtra, Karnataka and Tamil Nadu.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
