Rating Rationale

Acuite has reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.6.00 Cr. bank facilities of Hamd Foods Private Limited (HAMD). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Hamd Foods Private Limited (HAMD) was incorporated in 2005 at Ghaziabad (Uttar Pradesh). It is managed by Directors, Mr. Mohammad Haris and Mr. Mohammad Asad. The company is engaged in manufacturing and exporting of frozen beef meat majorly to UAE.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
