#### Rating Rationale

Acuité has downgraded the short term rating to '**ACUITE D**' (**read as ACUITE D**) from '**ACUITE A4**' (**read as ACUITE A four**) on the Rs.15.00 Cr. bank facilities of Vibrant Fab Private Limited (VFPL). The rating continues to be flagged as an 'Issuer Not-Cooperating' based on best available information.

The rating downgrade is based on the delays observed in servicing of the bank facilities availed by VFPL.

#### About the Entity

VFPL was incorporated in 2011 by Mr. Nirmal Desai and Mr. Hitesh Desai. VFPL is engaged in manufacture and wholesale exports of fabric & garments. The company outsources the manufacturing activity to manufacturers located in Surat. The company exports to countries including Dubai, UAE, Kuwait, Jeddah, Trinidad, Panama, Hong Kong, Singapore and Malaysia along with the domestic market.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
