Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.00 crore bank facilities of Paawan Energy (I) Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Kanpur based Paawan Energy (I) Private Limited (PEPL) was incorporated in 2010 and is promoted by Mr. Chandra Pal Yadav. PEPL is engaged the business of Engineering, Procurement and Construction (EPC) work for solar power plants. It is also engaged in O&M (Operation & Maintenance) of solar plant for third party.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
