Rating Rationale

Acuite has reaffirmed the long-term rating to '**ACUITE D**' (read as **ACUITE D**) on the Rs. 5.50 crore bank facilities of Kauten Kraft. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Gurgaon based, Kauten Kraft (KK) was established in the year 2015. The firm is engaged in the manufacturing and exporting of readymade fashion garments. KK is a 100% export oriented unit. The manufacturing facility is located at Gurgaon. KK exports to countries like U.S. and Europe, among others. Directors of Kauten Kraft Pvt Ltd are Rajnish Kumar, Kishor Kumar

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/ borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
