Acuité has reviewed its long-term rating of '**ACUITE B+** (read as **ACUITE B plus**) on the Rs.16.00 crore bank facilities of Alpine Shoes Private Limited. This rating is now an indicative rating and is based on best available information.

Alpine Shoes Private Limited (ASPL) incorporated in 2010 by Mr. Sanajay Leekha , Mrs. Charu Leekha and Mr. Hardeep Singh is engaged in manufacturing of sport shoes for men and women. The manufacturing facility is located at Baddi (Himachal Pradesh) with an installed capacity of 12,00,000 pairs of shoes monthly. The company manufactures for Reebok, Adidas and Bata.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
