Acuité has reviewed the long-term rating to **ACUITE B' (read as ACUITE B minus)** and short-term rating to **ACUITE A4' (read as ACUITE A four)** on the Rs. 11.70 crore bank facilities of Cool Caps Industries Private Limited (CC IPL). This rating is now an indicative rating and is based on best available information.

Cool Caps Industries Private Limited (CC IPL) was incorporated in the year of 2017 by Mr. Rajeev Goenka, Ms. Poonam Goenka, Mr. Arun Gourisaria and Mr. Vanshay Goenka. The company is engaged in manufacturing of plastic bottle caps with the installed capacity of 72 crore pcs p.a. The company has its registered office located at Kolkata, West Bengal.

Analytical Approach

Acuité has considered the standalone business and financial risk profiles of CC IPL to arrive at this rating.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
