Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 11.70 crore bank facilities of Cool Caps Industries Private Limited (CC IPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Cool Caps Industries Private Limited (CC IPL) was incorporated in the year of 2017 by Mr. Rajeev Goenka, Ms. Poonam Goenka, Mr. Arun Gourisaria and Mr. Vanshay Goenka. The company is engaged in manufacturing of plastic bottle caps with the installed capacity of 72 crore pcs p.a. The company has its registered office located at Kolkata, West Bengal.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
