Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 6.00 crore bank facilities of G. Thiruvengadam. This rating is now an indicative rating and is based on best available information.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
