Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-' (read as ACUITE B Minus)** on the Rs. 6.00 Crore bank facilities of G. Thiruvengadam. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

The Tamil Nadu-based, G Thiruvengadam (GT) was incorporated as a proprietorship firm in 2013 by Mr. G Thiruvengadam. The firm rents out its banquet hall for various functions including marriages, parties among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
