Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.15.80 crore bank facilities of Aqua Excel. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Aqua Excel was established as a partnership firm in 2014 located at Coimbatore (Tamil Nadu). The firm manufactures polyvinylchloride (PVC) pipes and fittings, Chlorinated polyvinyl chloride (CPVC) pipes and fittings, which are largely used in agriculture and construction sectors. The manufacturing unit is located at Peelamedu in Coimbatore with an installed capacity of 900 metric tonnes per annum (MTPA). The firm is promoted by four partners, Mr. K Ganesan, Mr. V Dinesh Kumar, Mr. A Ramasamy, and Mrs. M Nagamani. The firm sells its products under the brand name of 'Aqua Excel'.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions
