**Rating Rationale**

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) and reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 5.00 Crore bank facilities for B S SATHISH KUMAR on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

Karnataka Based B S Sathish Kumar (BSSK) was formed in the year of 1997 by Mr. BS Sathish Kumar. The firm is engaged in civil construction work for Public Works Department (PWD) of Karnataka government and Karnataka Rural Road Development Agency (KRRDA).

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
