Acuité has downgraded the long term rating to '**ACUITE BB-**' (**read as ACUITE double B minus**) from '**ACUITE BB**' (**read as ACUITE double B**) on the Rs. 10.00 crore bank facilities of Surya Global Hospitals Private Limited(SGHPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

SGHPL is a Kakinada (Andhra Pradesh) based hospital established in 2010 and promoted by Dr. Bhupatiraju Karuna and Dr. Bhupatiraju Pitchayya Sri Veerraju. The company runs a 250-bed multispecialty hospital located in Kakinada. The hospital offers a range of healthcare facilities in the fields of Cardio Thoracic & Vascular Surgery, Surgical & Radiation Oncology, Orthopedic, Neuro & Spine Surgery, General Medicine, Critical Care, Obstetrics and gynecology, Nephrology, Urology, Ent Surgery segments among others.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
