Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 10.00 crore bank facilities of Surya Global Hospitals Private Limited (SGHPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Surya Global Hospitals Private Limited (SGHPL) is a Kakinada (Andhra Pradesh) based hospital established in 2010 and promoted by Dr. Bhupatiraju Karuna and Dr. Bhupatiraju Pitchayya Sri Veerraju. The company runs a 250- bed multispecialty hospital located in Kakinada. The hospital offers a range of healthcare facilities in the fields of Cardio Thoracic & Vascular Surgery, Surgical & Radiation Oncology, Orthopedic, Neuro & Spine Surgery, General Medicine, Critical Care, Obstetrics and gynecology, Nephrology, Urology, Ent Surgery segments among others.
