#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.11.00 crore bank facilities of PUTHUPALAYAM TIMBER INDUSTRIES (PTI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

# **About the Company**

Tamil Nadu based Puthupalayam Timber Industries was established as a partnership firm by Mr. R. Velayutha Raja, Mrs. V. Vidhya Gayathri and Mr. Rithish Krishna in 1978. PTI is engaged in wholesale trading of imported timbers such as Teak Logs, Merbau Saw Timbers and Mora Logs. The firm imports timber from Hong Kong, Malaysia and Singapore and sells to Jhonson Wood Industries, Sri Kumaran Industries and others.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
