Rating Rationale

Acuite has reaffirmed the long-term rating of **‘ACUITE D’ (read as ACUITE D)** on the Rs.30.00 crore bank facilities of Harman Rice Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Punjab based Harman Rice Private Limited was incorporated in 2006, by Mr. Dalip Singh and his son Mr. Bhupinder Singh. The company is engaged in the production of both basmati and non-basmati rice with their manufacturing facilities located in Bhatinda, Goniana, with capacity of 6 tons per hour. The company generates its revenues via both exports and domestic sales. The exports are towards Middle East countries, New Zealand, Canada, US and domestic markets are from Delhi, and Gujarat.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
