Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 8.50 crore bank facilities of Sri Lakshmi Srinivasa Roller Flour Mills. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sri Lakshmi Srinivasa Roller Flour Mill (SLSRFM) is a Bangalore based partnership firm established in the year of 1998 for the purpose of carrying on business of manufacturing atta, maida, suji and brans. The current installed capacity is 120 MT per day. Currently, the business is run by MS Suraj and MS Sujan and their profit sharing ratio is 50-50 per cent. In August 2015, SLSRFM reconstituted its partnership deed where previous partners RP Seetharam and Ajaykumar RP express their inability to continue as a partner and retired from the partnership business.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
